ELECTRICAL REGULATIONS

Would exhibitors please note that special electrical regulations apply to all major exhibition venues.

A few that may be relevant to you are:

- 1. All electrical connections must be enclosed (no strip connectors).
- Only one extension block lead of not more than 2m long to be used in each socket.
- 3. Adaptors and reel type extensions shall not be used.
- 4. Leads on exhibitors' equipment not more than 2m long.
- Maximum loading of lighting on ONE socket is 1000w.
- All metal fittings and equipment must be earthed.
- If you use your own equipment it must comply with all regulations and is subject to testing and spot checks. 7.
- Not more than one flex to one plug top.
- Sockets must not be overloaded i.e. 500w sockets only 500w maximum.
- 10. PORTABLE APPLIANCE TESTING (PAT): All electrical equipment should have been tested before arriving on site and have the relevant confirmation sticker attached.
